1	Apologies – Dist Cllr Peter Moseley (PM2). Absent -, County Cllr Martin Hill (MH), Cllr Peter Morris (PM1)	
2	The Chairman welcomed all present.	
3	No members of the public were present	
4	Declarations of Interest – None.	
5	Minutes of the Last Meeting – agreed and signed. Proposed by MD and seconded by JP.	
6	Matters Arising The comment on JL's spelling in the last minutes should be removed. Any other matters arising will be dealt with in the relevant sections below.	
7	Planning JL said he had received 2 notifications from planning with respect to recent applications. Ms Carr-Bilas application to demolish a garage and rebuild with addition accommodation had been granted. Mr Barrington had withdrawn the application to a barn to a single dwelling at Laughton Lodge Farm, had been withdrawn.	
8	Cemetery Nothing to report.	
9	Neighbourhood Watch Nothing to report. However, FC said that the PCSO had attended a meeting in Morton and reported that there had been a further spate of thefts from sheds and outbuildings in Rippingale and Morton so the public should stay vigilant.	
10	Highways JL said he had been back on to Lincolnshire Highways re all the potholes in the village and going up to the airfield. The 3 largest ones by the factory and Cemetery have been partially filled in and were a lot better but still not perfect. One had only been half filled in. The rest remained untouched.

	<p>JL said the large one across the road near the Laughton turning had been filled in but now the tarmac was above the road level and so created a hump in the road. He also mentioned that he had been speaking to someone the other day whose wife had hit a large pothole on Mareham Lane and burst two tyres and damaged wheels, apparently when her husband had reported it he was told that it had already been reported 100 times previously.</p> <p>BW said he had seen the Leader of the County Council the other week and he had mentioned that he had had to report some pot holes outside of his home. BW also said that when he drove back past a few days later these potholes had been filled in. A comment was made asking was this an abuse of position but BW thought not.</p> <p>JL will continue to monitor the pot hole situation and report accordingly.</p> <p>BW said that he had spoken to the grass cutting contractors and they were hoping to start cutting the grass this Wednesday but it would be weather permitting. They had apologised for not being here sooner but it was purely because the ground was too wet.</p> <p>BW said he had received a couple of complaints that certain areas in the village were not cut but had explained to residents that this was due to these areas not covered by the contract, mostly due to them not being adopted by LCC. He had also informed the residents that if they approached the contractor he would willingly cut these areas for a fee.</p> <p>FC said she had received notification that the whole of Temple Road, Aveland Way and Kirkby Underwood Road would be closed the whole length at some point between 13/04/2018 and September for resurfacing work. Hopefully this will cure the pot hole issues. Diversions will be in place.</p> <p>JL said he had received notification of the grass verge cutting timetable. The first cut will be between April and May and the second cut between August and September.</p> <p>Footpath No 4 – the PC had continued to maintain this over the last year and would pay the invoice for the work. However, it was decided that next year they would not and see what happened.</p> <p>Also one of the neighbouring properties to the footpath had coppiced their hedge which has now collapsed into the footpath.
