National Grid – Great Grid Update – Weston Marsh to East Leicestershire National Grid has introduced proposals for approximately 37 ½ miles (60 km) of new 400 kV (400,000 volts) overhead power line from Lincolnshire to Leicestershire (https://www.nationalgrid.com/the-great-grid-upgrade/westonmarshto-east-leicestershire). The preferred corridor will carve a swathe of pylons 165 feet (50 m) high and 328 yards (300 m) apart through southern Aveland. If approved, the effects of this project will be felt throughout the Ward.
